Lead Testing Kit Instructions

Once you receive your SLGi Lead Testing Kit, verify the contents:

- 1) SLGi's Informational Tri-fold
- 2) United States Environmental Protection Agency (EPA) Brochure on Lead
- 3) Chain-of Custody Form including instructions for kit use
- 4) A return shipping label

Instructions for completing a Chain-of-Custody Form:

- 1. Unfold your Chain-of Custody Form.**
- 2. Complete the Contact Information Section.**
- 3. Check the appropriate Payment Method Box.** The kit that is being sent to you is FREE, but there is an analytical fee for each test. The analytical fee is \$25.00 per item submitted. Each kit can accommodate from 1 to 5 tests with an additional (6th) test FREE if ordering 5 tests.
 - a. Credit Card: SLGi will call you when your items have been received and will ask for your Credit Card Information
 - b. Money Order – enclose with items
 - c. Check – enclose with items
- 4. Label each item.** (toy, cosmetic, jewelry, ceramic, etc) that you are sending with a number (1,2, 3...)
- 5. After each number** (entered in the section labeled SAMPLE ID, **describe each item.**

Sample ID	Sample Description
1	Red painted train engine - toy
2	XXX brand lipstick – wine color
3	Wipe of lead paint – child's room #1

- 6. Place each item in separate bags and place them in the original kit envelope.** (If your items are too large, you may send them in any other larger box of your choice.)
- 7. Fold the Chain-of Custody Form and place it in the envelope.** (Do NOT put it in the zip lock bags with your items.)
- 8. Tape the envelope securely.**
- 9. Place the RETURN LABEL over the existing label.**
- 10. Mail from your US Post Office.**
