DISPOSAL POLICY

In the course of analysis, SLGi may receive excessive weight of hazardous sample material (including soil, paint and bulk materials), requiring special disposal procedures. To ensure that we can continue to offer the best prices and service, SLGi charges \$50/sample for disposal of material beyond the amounts described below.

Test	Excessive Amount (greater than)
TCLP Metals or Organics	> 250 grams or 1/2 pound
Full TCLP, Metals and Organics	> 600 grams or 1.5 pounds
Bulk PCB	> 20 grams or 1/4 cup
Metals	> 60 grams or 1/2 cup
Bulk Asbestos	> 4" by 4" (4 inches-square)
Loose Debris Asbestos	> 20 grams or 1/4 cup
Vermiculite (float method)	> 225 grams or 1/2 pound

Schneider Laboratories Global Sample Storage Policy

Schneider Laboratories Global, Inc.
